VDOT requests that the Hampton Roads Transportation Planning Organization (HRTPO) amend the FY 2015-2018 TIP to add project UPC #110634 – Nansemond Parkway / Wilroy Rd Overpass over Commonwealth Railway with cost estimate, allocations, and obligations. Project purpose is to eliminate the existing at grade crossing by realigning the intersection of Nansemond Parkway and Wilroy Road in order to provide a grade separated overpass for Nansemond Parkway over the Commonwealth Railway tracks, approximately 0.72 mile. The requested changes can be accomplished via an TIP amendment to the HRTPO's TIP. To that end we request UPC 110634 be added including the following information to the FY 2015-18 TIP:
