The Greater Virginia Peninsula Homelessness Consortium (GVPHC) is a regional body comprised of six jurisdictions: Newport News, Hampton, Poquoson, Williamsburg, James City County and York County. The mission is to develop, sustain and coordinate comprehensive continuum of care for citizens at risk of, and experiencing homelessness. GVPHC also serves as a regional Continuum of Care (CoC), the forum responsible for coordination and management of federal and state funding for homeless services. Hampton Department of Human Services is the designated CoC Lead Agency with facilitation and coordination assistance provided by The Planning Council.

The Lead Agency for facilitation and coordination is the Portsmouth Department of Social Services, with consultation assistance from The Planning Council. SVHC works to engage individuals, groups, and organizations throughout the community, including faith partners and members of the private sector that provide services to persons experiencing homelessness or have an interest in the process. Persons who have experienced homelessness are also encouraged to attend meetings and join committees.

SVHC serves as a regional Continuum of Care (CoC) organization, responsible for coordination and management of local, federal and state funding for homeless services. Facilitation and coordination is provided by The Planning Council. SVHC recognizes five committees: the Governance Board, Program Monitoring, HMIS & Data Collection, Singles Services Coordination and Families Services Coordination.


